

11. Grievance Redressal Mechanism for Faculty and Students

Students grievances must be represented individually to their respective class coordinator and it should be settled within 48 hours. In case, if it needs attention of higher authorities, it should be routed through the respective Dean. Time limitation for solving at Dean level is 48 hours at their hands. If not possible it should be submitted to Principal for further assistance. Therefore, the ultimate time limit to address the grievance is one week after submitting the representation. Collective representation of grievances must be routed through their representatives and immediate actions are to be taken for arriving the solution. In no other form the grievances will be addressed. Therefore, students are advised to follow the said system.

Grievances of the faculty will be addressed based on the representation from individual faculty members only. The collective grievances must be represented through their respective HOD's. Individual representations are to be forwarded to Principal through HOD & Dean. The processing delay at each staff is 24 hours on the receipt of representation. A register entry is to be made at Principal's office. The solution will be arrived within 4 working days. Time duration for collective representation depends on the nature of grievances and it will be decided later.




